



Course Offered - AYURVEDACHARYA - B.A.M.S

Eligibility : The candidate must have passed intermediate (10+2) or its equivalent examination recognised by the concerned State Government and Education Board with the subjects of Physics, Chemistry, Biology and English individually and must have obtained minimum of fifty per cent. marks taken together in Physics, Chemistry and Biology at the aforesaid qualifying examination in the case of general category and forty per cent. Marks in the case of the Scheduled Castes, Scheduled Tribes and Other Backward Classes for Karnataka State candidates. Admission is made on the basis of NEET Examination conducted by NTA Constituted by Government of India. Minimum 50 percentile is required to eligible for NEET and as per Rules & Regulations Made by NCISM

Age for admission: Minimum 17 years & Maximum 25 years as on December 31st of academic year.

Medium of instruction: English

Admission Procedure: Eligible candidates may Register for Karnataka Examination Authority thorough online with prescribed fees and date thorough counselling seats are allotted to our Institute their offer admission application form is submitted in person during working hours of college after proper verification of all essential documents.

Degree to be awarded.-The candidate shall be awarded Ayurvedacharya (Bachelor of Ayurvedic Medicine and Surgery-B.A.M.S)

Electives (Minimum Three) subjects

Electives.-(i) Electives are introduced in B.A.M.S. curriculum to provide opportunity to student of Ayurveda to get introduced, exposed and oriented to various allied subjects that are required to understand and build inter-disciplinary approach. (ii) The electives shall be conducted as online programme. (iii) Each elective subject shall be of forty-five hours duration and divided in five modules and each module shall have nine hours i.e., five hours of teaching, two hours of guided learning, one hour each for expert interaction/reflection and assessment and in total, each elective will have twenty-five hours of teaching, ten hours of guided learning, five hours of expert interaction/reflection and five hours of assessment (iv) The study hours for electives are over and above the prescribed teaching hours of B.A.M.S. under these regulations.

Clinical training.- (i) Clinical training of the student shall start from the First Professional session onwards and subject related clinical training shall be provided in the attached hospital by the concerned faculty and department in non-lecture hours as per the requirement of the subject as under-

(a) During first professional session, clinical training shall be provided by department of Samhita & Siddhanta and Kriya Sharira through the specialty Outpatient Department (OPD) and Inpatient Department (IPD) where in teachers of the above departments are consultants and screening OPD; wherein students involve in Prakriti and Saara assessment, practicing of naadi, recording of dosha vridhhi kshaya lakshanas, measurement of height, weight, calculation of Body Mass Index (BMI) etc. activities.

(ii) (a) Clinical training for the Second Professional session shall be as per clinical attendance shall be maintained by the concerned faculty and department.

(b) Clinical training for the Second Professional session shall be provided in accordance with the requirement of subjects as under-

(A) i. Department of Roganidana will provide clinical training through specialty clinics and IPD wherein teachers of Roganidana department are consultants.

ii. Department of Agada Tantra through Visha Chikitsa OPD and IPD.

iii. Department of Swasthavritta through swastha rakshna OPD and IPD.

(B) In addition, the second professional B.A.M.S. students shall be posted to medicine dispensary to get familiar with prescription patterns, medicine names, forms, dosage, Aushada sevanakaala, anupana, sahapana, method of mixing or compounding of medicines etc. Similarly, in IPD nutritional assessment, pathya preparation unit or diet center to get familiarize with various pathya or therapeutic diet preparations.

(iii) The clinical training (OPD and IPD/Operation Theatre/Labour room/Pancha Karma therapy room) during the third (Final) Professional session shall be on rotation basis as per the non-lecture/clinical batches and in accordance with the clinical/non-lecture teaching hours stipulated for the following subjects, namely:-

(a) Kayachikitsa: OPD, IPD and specialty clinics functioning under the department if any;

(b) Panchakarma: OPD, IPD, Panchakarma therapy rooms including preparation room and any other related specialty units or clinics if any;

(c) ShalyaTantra: OPD, IPD, operation theater (major and minor), any specialty units like sports medicine, marmachikitsa, bhagnachikitsa etc.;

(d) Shalakyatantra: Eye, ENT, dental clinic, kriyakalpa and any other related specialty clinics if any;

(e) Streeroga evam Prasuti: OPD, IPD, labour room, procedural room (yoni dhavana, yoni dhupana, yoni pichu, uttarabasti etc.), garbha samskara, and other related specialty clinics if any;

(f) Kaumarabhyta: OPD, IPD, pediatric panchakarma rooms and other related specialty clinics if any; and

(g) Samhita & Siddhanta: Specialty clinics/units like madhumeha, hridroga, medoroga, sthoulya, asthi & sandhi etc.

Compulsory Rotatory Internship.- (i)The duration of Compulsory Rotatory Internship including Internship Orientation Programme shall be one year and ordinarily commence on first working day of April for regular batch students and first working day of October for supplementary batch students. (ii)The student shall be eligible to join the Compulsory Internship programme after passing all the subjects from First to Third (Final) Professional examination including nine electives and after getting Provisional Degree Certificate from respective universities and Provisional Registration Certificates from respective State Board or Council for Compulsory Rotatory Internship.

Activities during Internship.- The daily working hours of intern shall be not less than eight hours; the intern shall maintain a e-logbook containing all the activities undertaken by intern during internship.

Completion of internship: If any delay in the commencement of internship or abnormal break during internship due to unavoidable conditions, in such cases internship period shall be completed within maximum period of three years from the date of passing the qualifying examination of Third (Final) Professional B.A.M.S including First and Second Professional subjects and nine electives, specified as eligibility for internship:



DETAILS OF FEES

- Tuition fee as laid down and fixed by respective governing or fee fixation committees as applicable shall be charged for four and half years only
- The fee should be paid in the college office on or before 30th of June every year, Annual fee remittance is at the time of promotion to next class. The candidate will lose his/her attendance if he/she does not pay the fees within 15 days from the due date with disciplinary action.
- Candidate selected for admission to the college should pay the first installment of fees on the date of admission. Fees once paid will not be refunded in any case. Cash transactions will be made through NEFT/RTGS only. No other modes are permissible.
- A receipt shall be given for every remittance made. Mistakes if any in receipts issued for payment should be pointed out and be corrected on the spot. Complaints made later will not be considered. Rules do not permit the issue of duplicate receipt for any future requirements.

ATTENDANCE AND LEAVE OF STUDENTS

- * Attendance shall be marked at the beginning of each class, whether theory or practical, by the member of the staff in charge of the class. Students should occupy their respective seats before attendance is taken. They should not leave the classroom nor should the late comers enter the classroom without the permission of the teacher in charge of the class. No student shall absent himself from a class without leave. Absence without leave for a part of a session shall be considered as absence for half day.
- * The student coming to class late without leave shall lose attendance for that period unless otherwise recommended by the teacher in charge of the class.
- * All application for leave should state clearly the number of days and the days for which the leave is required and give fully the grounds for the application. If leave is required for a single hour only, application may be made to the teacher in charge of the class during the hour and the same will be forwarded to the Principal with the remarks. If grounds of application for leave are not clear or satisfactory, the students may be called for explanation or the leave may be refused.
- * In case of unforeseen circumstances, the leave application should be submitted not later than the first day of return to the College to be treated as absent for hostel.
- * Students absenting themselves without leave for more than 5 consecutive working days without satisfactory explanation reason will be removed from their rolls of the College. They may be re-admitted at the discretion of the Principal.
- * Students should secure at least 80% of attendance separately in theory and practical in each subject to obtain NOC of attendance.
- * Disciplinary action will be taken against those who repeatedly absent themselves on insufficient grounds.

COLLEGE UNION

The office bearers of the **College** union are selected according to the merit basis of **University** results. There is an active **College** union in the college which functions through various Sub-committees. RULES FOR COLLECTION AND REFUND OF CAUTION DEPOSIT:

- Every student on admission to the college at the commencement of the course be liable to pay the caution deposit prescribed for that course at the rates prescribed along with the first installment of tuition fees and other fees.
- The caution deposit to be paid by a student for the course shall be retained in the institution till completion of the course of study. At the end of the course of study, the caution deposit collected from the student will be refunded to him /her on receipt of application from the student in the form prescribed after adjusting the dues, if any on account of loss of library books/recovery of fine for breakages of laboratory equipment's and any other loss caused to the properties of the college & hostel. Arrears of fees if any. If the caution deposit is less than the amount to be realized from the student, the excess amount will be realized by other means as the principal may decide.
- The students should keep in safe custody the receipts issued for remittance of caution deposit amount during the tenure of the course. The caution deposit amount will be refunded only if the concerned receipt issued from the college is produced along with the application for refund of caution deposit. Failure to produce the original receipt will result in forfeiture of the claims for refund.

INTERNAL ASSESSMENT EXAMINATIONS:

Three internal examinations shall be conducted in each subject during a year and average marks of two best performances shall be taken into consideration for the award of internal marks. Marks of Evaluation by other methods like assignments, seminars, projects etc. can be added to the internal marks. A candidate must obtain 50 % of marks in internal assessment to be eligible to write the university examination. The minimum marks required for passing the examination shall be 50% in theory and practical separately in each subject. The following criteria may be taken into consideration for determination of Student's eligibility for NOC and other awards

Department of Samhita Siddanta & Sanskrit

The Samhita, Siddhanta and Sanskrit Department have lecturers who teach Ayurveda subjects and Sanskrit language as per the course syllabus. In the curriculum of BAMS course, the teachers of the department guide the students of all the years as Samhita Adyayana. The main activities of the department include conducting different activities like Samskrit Shibira (trying to communicate in Sanskrit by speaking in Sanskrit language by the students), Ashtanga Hrudaya Parayana (reciting the Slokas of Ashtanga Hrudaya Sootra Sthana as a continuous exercise), etc.

- On the occasion of International Sanskrit Day, Sanskrit Day celebration was conducting every year as one of activity of the department.
- On the occasion of Charaka Jayanti, Charaka Jayanti was being celebrated every year with different programmes by the department.
- The aim of the department is for providing exquisite knowledge on the basic principles of Ayurveda and giving related



Department of Kriya Shareera

Kriyashareera is the science which deals with the study of human body in its physiological aspects. The department studies the normal concepts relating to the body functions both in Ayurveda and modern context. The knowledge of human physiology is essential to understand various body mechanisms which will be helpful to be attentive of the pathological conditions in the diseased state which serves the foundation of medical science. The underlying goal is to explain the fundamental mechanisms that operate in a living organism and how they interact. Department of Kriyashareera is well equipped with charts, specimen, models, books for teaching and learning purpose, along with well-equipped laboratory to teach all Ayurvedic and modern practicals. As a discipline, it bridges the science, medicine, and health, and constructs an outline for understanding how the human body adapts to stresses, physical activity, and disease.

Department of Rachana Shareera

Department of Rachana Sareera stands as one of the important pillar of basic principles of Ayurveda. It deals with the study of Structure of the Human Body and topics like embryology or Developmental Anatomy, histology, Anthropometry, Genetics, marma shareera etc as per Ayurveda and Modern science. The Rachana Sareer subject comprises study of Normal body structures documented by Ayurveda and the Acharyas as well as the study of Modern Anatomy.

Department of Dravyaguna Vignana

Dravyaguna vijnana (Clinical pharmacology) is an integral part of Ayurveda, which comprehensively deals with various aspects of medicinal plants explained in Ayurveda classics such as their identification, understanding their properties, action and therapeutic uses etc. The department aims at equipping the future generation of Ayurveda community by providing perfect training and mentoring to BAMS students in the college. Propagating information about Medicinal plants, promoting conservation and cultivation of rare and valuable plants etc. are some of the core activities of the department.

The highlight of the dept is a well-maintained herbal garden with more than 300 species of herbs, shrubs and trees having medicinal values. The herbal garden aids in providing practical knowledge to the students for the identification of medicinal plants and also in the conservation of many rare species.

The department maintains a reference museum where samples of various dry and wet specimens have been displayed along with their photographs and charts. The department includes a spacious pharmacognosy laboratory with all necessary equipment like microscope and various chemical reagents to train the students in their practical classes.

Department of Rasashastra and Bhaishajya Kalpana

The Department of Rasashastra and Bhaishajya kalpana deals with pharmaceuticals of Ayurvedic drugs. It is the only branch in Ayurveda which deals with the uses of heavy metals and minerals in medicinal form. The students get to know about the methods of preparing these metals and minerals by various procedures like purification and incineration for therapeutics. By strictly following the Ayurveda principles, this subject equips the students with all knowledge of formulating and preparing medicines according to the patient.

Infrastructure facility of the department includes Staff room, Drug museum, Analytical laboratory and Pharmacy.



Department of Roganidana and Vikruti Vignana

Department of Roga Nidana contributes to the field of aetiopathological and clinic-pathological studies in several diseases. This subject is meant for postulating principles of Ayurvedic Diagnosis at clinical as well as laboratory level. It is the chief subject that connects the physician with patient and then to medicine. This department is involved in various laboratory diagnostic investigations and pathological tests for patient's care. A well equipped laboratory is attached with this department for that particular purpose. Apart from this, the department mainly deals with the subject that helps the students to know the fundamentals of a disease in terms of etiology of the disease, clinical features, pathogenesis and prognosis and the means to examine the diseased individuals. Department possess good number of models, charts, specimens and laboratory instruments



Objectives

- To give knowledge regarding basic concepts of roga nidana and basic concepts of modern pathology.
- To perform bedside clinical examination and for improving the skill of history taking by demonstrations and its practice on patients
- To understand various steps involved in performing laboratory investigations and its clinical importance
- To practice the tools of investigations like USG, X- ray, ECG, CT etc.
- To promote research practices in order to set protocols to diagnose the disease with the aid of fundamentals.

Department of Agadatantra and Vidhivaidyaka

Agada Tantra is one of the Astangas of Ayurveda, dealing with toxicology. With advancement of health sciences, relationship between toxins and health has been scientifically proved. Hence Agada Tantra branch becomes highly relevant in today's context by providing better options in the management of various toxic conditions. Cumulative toxicity deals with accumulation of poison in the body through everyday consumption of unhealthy food, unprocessed and junk foods. It becomes a mandatory measure to understand it for better approach in management.

Department activities includes, preparing the graduates to manage various toxic conditions and the condition of cumulative toxicity. Training the graduates in Ayurveda toxicology and medical jurisprudence in academic.



Department of Swasthavritta and Yoga

Swasthavritta is a branch of Ayurveda which deals with maintenance and promotion of health and disease prevention. Swasthavritta addresses all dimensions of health through proper daily and seasonal regimen, proper dietetics, advocating code of good conduct for mental health and social behaviour and so on. Principles of Yoga and Naturopathy are also assimilated for the health and wellness of public and private health. The Department has 6 days OP Consultation where Life style disorders are managed by diet and lifestyle modification, medication, yoga and pranayama consultation and nature cure techniques.

To prevent and manage diseases on a community level, Health awareness classes and Medical camps are being conducted in different educational institutions, Panchayath level and at different villages. Yoga and naturopathy is an important wing of this department. Yoga and Pranayama consultation and training are being given for OP and IP patients. Department has a Museum with specimens of various food articles which have to be included for a healthy diet, which helps the students to easily identify them. Museum also has Models of Social and Preventive Medicine. Specimens of Yoga and Naturopathic practice are also present. Department has a Yoga hall exhibiting charts of various Yogasanas. Training for students and patients are given in this Yoga Hall.



Department of Kayachikitsa

The Kayachikitsa department offers teaching and training modules on general medicine. It comprehensively deals with the diagnosis, assessment of the patient, investigation and effective medical management of various ailments according to the fundamental principles of Ayurveda. The treatment side consists of the usage of a wide variety both internal medicines and external treatment procedures. The management modality is selected after careful assessment of various constitutional factors of the body and morbidity factors. So, we are providing with:

- Expert consultation for which treatment to undergo.
- Short course as well as complete detoxification procedures.
- Ayurvedic Immunity boosting measures.
- Cosmetic issues and maintain skin health.
- Therapeutic massage and steaming to rejuvenate the body.
- Extended service to give counseling to maintain psychological Health.
- Palliative as well as curative treatment of Joint disorders, neurological disorder.
- Gastroenterological disorders as well as metabolic disorder.
- Expertise in the urinary tract and respiratory disorders. etc



Department of Panchakarma

In the current era human beings are more exposed to acute & chronic poisoning, pesticide, chemical preservatives etc. Most of the chronic diseases of the modern times are caused by these deep seated metabolic toxins. Panchakarma not only eliminate the disease causing toxins but also revitalizes the tissues. This is why it is popularly known as Rejuvenation therapy.

Vamana – Vamana is the therapeutic procedure where forceful expulsion of vitiated doshas occurs through mouth following administration of Vamanoushadhi



1. Virechana – Virechana is a procedure in which the prakupita doshas are expelled through adhomarga by the administration of medicines through oral route.

2. Asthapana Basti – Asthapana/Nirooha is the procedure where, combinations of medicaments are administered through rectal route, for local as well as systemic effects.

3. Anuvasana Basti – It is used in two ways as a supportive treatment for asthapana in different protocols like yoga, kala, karmavasthi and as a kevala snehavasthi in the form of matravasthi.

4. Nasya – This is a procedure wherein medicaments are instilled into nasal cavity in doshas especially pertaining to uttamanga, to achieve desired multidimensional effects.

These are done in specific manner- First Poorvakarma (Pre-operative procedures), then Pradhanakarma (Operative procedures) & finally Paschatkarma (Post-operative procedures). Panchakarma is a Final Professional B.A.M.S clinical subject. Institute provides Hands-on training in Panchakarma along with in-depth focused theory sessions by subject experts.

Department of Shalyatantra

Shalya Tantra deals with surgical and parasurgical procedures like Bheshajakarma, Yantrakarma, Shastrakarma, Raktamokshana, Ksharakarma, Agni karma, etc. in treating diseases such as ulcers, ano-rectal, orthopedic / marma related and other related ailments. Our in-patient unit adopts surgical, parasurgical & marma related techniques to manage ailments with cost effective and faster recovery periods. The department is committed to impart excellence in academics, clinical and surgical training for undergraduate scholars. Our vision is to cultivate Shalyatantra practitioners with integrity, knowledge & skill. Department prepares the graduates to cater to the health needs of society. Train the students in Ayurvedic surgical, non-surgical techniques and ethics. Exploring the unexplored areas of research in Shalyatantra and provide hand to hand surgical training to provide clinical excellence.



Department of Shalakyatantra

Shalaky Tantra is a branch which deals with the health care of Eye, Ear, Nose, Throat, Oral & Dentistry and Head. These being the vital sensory organs, there is a direct need to protect and preserve the health of these organs, hence known as Uttamanga Chikitsa Tantra. It has Outpatient department for Eye, ENT and Dental separately, with well-equipped Kriya Kalpa Unit, Eye Exercise Unit, MOT Unit and major operation theater for Eye & ENT separately.

Our Mission is to train the scholars to teach Ayurveda Ophthalmology & ENT in academics, Research orientation in unexplored areas of Ayurveda Ophthalmology & ENT and Hand to Hand Surgical training to provide clinical excellence. This department prepares the students to manage many diseases that affect the eye like diabetic retinopathy, glaucoma, macular degeneration and the diseases related to ENT.



Department of Prasuti tantra and Streeroga

Our highly qualified team of professionals deals with overall women's health and treatment of gynecological disorders. We provide preconception care and special month wise care for pregnant ladies to beget a healthy progeny. The department excels in giving service to every phase of womanhood like adolescents care from menarche; reproductive care includes antenatal and postnatal care and premenopausal care. Specialty clinics are there for PCOD, fibroids, heavy menstrual bleeding, infertility, pre conception care and counseling.

Our peer team is here to provide excellent academic outreach which nurtures the medicos in their proficiency and to conduct researches in the field of current health scenarios. Department imparts value based awareness programs to the public through medical camps, social medias and online platforms.



Department of Kaumaryabritya

Department of Kaumarabrithya deals with complete child care, since childhood is the foundation of future health. The department is imparting teaching and training to undergraduate BAMS students along with outpatient and inpatient care for various ailments like developmental disorders, genetic disorders nutritional disorders, respiratory disorders, skin disorders neuropsychological disorders gastro intestinal disorders, Juvenile rheumatic disorders. Department conduct screening camps on various child health care programs like suvarnaprasana camp, school health checkup, health awareness programs, counseling sessions for both parents and children.



General Regulations of Library :

The College Library will be under the general supervision of a Library committee which is under the ultimate control of the Principal. The Librarian will be the custodian of all documents in the library. Library Automation implemented by using Software

Library Timings :

Working Hours : 9.00 AM-6.00 PM on all working days. Circulation (Issue& Return) : 9.15 AM -5.45 PM. The library will remain closed on all public holidays. The timings and days of operation shall undergo changes. The library membership is primarily meant for bonafide Students, House Surgeons, Faculties and Non Teaching Staff of the Institution. The library provides free Internet facility for students. Users are generally limited to half an hour for using Internet. The Dept. Libraries are under the control of the Central Library. Transfer of books among departments is not allowed. It can be done only with the permission of the Principal through the Central Library. Overcoats, Bags, Files, Folders, Laptops, Covers, Printed Materials, Photocopied and Non -book Materials and similar personal belongings shall normally be deposited in the property counter. One note book / loose sheets of papers are only allowed to be used inside the library. Silence must be observed strictly in the Library. The library must be a quiet place for individual study and research. The use of mobile phones inside the library is prohibited. Users are requested to leave the books/documents on the reading table after consultation. An announcement will be made ten minutes before closing time and all users must vacate the library.

Circulation of books :

The circulation (Issue & Return) system of books is completely automated and the users have to produce their College ID cards with bar code (library membership number) on the reverse side for borrowing the books. Books and Periodicals classified as 'REFERENCE' shall not be issued. Borrowing privileges for each member is determined by his/her membership category. Members are not allowed to exchange books from one to another. Library materials borrowed must be returned or renewed on or before the due date. In order to get renewal on library books, members must bring the items to be renewed to the library. Absence from the college will not be accepted as an excuse for delay in return or renewal of the books. Overdue library materials are subject to fines. While charging the fine vacations will be counted. All borrowers must settle any overdue loans before they are permitted to borrow again. This policy is applicable to all categories of borrowers. The Librarian may recall any at any time even if the period of loan has not expired. Lost/damaged materials should be reported to the Librarian on time. Librarian is empowered to withhold library facilities for any infringement of these rules.

Non Liability Certificate :

The Non Liability Certificate which is essential for getting Certificates shall be issued from the library only after clearing the dues and liabilities in connection with library activities.

1. At the time of admission to hostel, each student is required to submit a duly filled application form. The student should apply in person at the time of admission for every year in the month of June on first come first basis after receipt of hostel fees.


